

Rules of the 41st TOURIST RECREATIONAL CYCLING MARATHON AROUND POHORJE

1. Organiser

2. Terms of Participation

All, who accept the rules of participation, can participate at the 41st tourist recreational cycling marathon around Pohorje (hereafter referred to as: marathon).

3. Marathon Timetable

Date of the event: 22nd June 2019

Start: Trg svobode, Maribor, 9 a.m.

Finish: Trg svobode, Maribor, platform in front of Vinag, from 10 a.m. to 4 p.m.

Issuing of Starting Numbers: on Friday, 21st June, from 3 p.m. to 6 p.m., and on Saturday, 22nd June, from 7.30 a.m. at the event tenth of KD Branik at Trg svobode.

Applications: You can submit your marathon application over the website www.okolipohorja.si or apply at the event tenth at Trg svobode Maribor two days prior to the event.

Entry Fee:

1st February – 1st May: 18 EUR (incl. VAT)

2nd May - 16th June: 25 EUR (incl. VAT)

17th June - 21st June: 30 EUR (incl. VAT)

on the day of the marathon: 35 EUR (incl. VAT)

The entry fee includes a cycling jersey, a starting number, a commemorative medal and a warm meal with a drink at the finish line.

4. Rules of Participation

Every cyclist who enjoys organized and recreational cycling events and is able to complete a 25 km, 50 km, 72 km or 147 km cycle ride is allowed to participate in the marathon. Cyclists up to 14 years of age are only allowed to participate in the race if accompanied by their parents or someone aged 18 or older. Cycle helmets are compulsory for all participants. On the 147 km course participants will ride in a closed group at the speed of 27 to 30 km/h. Maribor police will take care for order and safety of the group with removable a traffic barrier. Cyclists will take a longer break in Mislinja. The marathon will take place in any weather conditions, all roads will be open to traffic, so normal road rules and organizer instructions must be obeyed. Marathon participants ride at their own risk and are liable for any damage they cause to themselves or other persons. The organizer accepts no responsibility for damage, which cyclists cause to themselves, other cyclists or to a third party. During the race it is strictly forbidden to overtake the accompanying cars at the head of the group. With the start each cyclist confirms that they are aware of the marathon rules, published in daily press and other media and at the event itself. Organiser with his cars, medical services and security officers will ensure the safety and security of the event.

5. Other Marathon Terms and Conditions

Due to unforeseen circumstances, cases of force majeure, the organizer can terminate or finish the marathon early without prior notice. The organizer must inform the participants about marathon cancellation or its earlier ending over the media. In such case the organizer is not liable for any damage to participants. The organiser's decision about all questions, related to the marathon, is final and valid for all participants. The organiser reserves the right to limit occasional limited access to the website due to maintenance work or troubleshooting, equipment upgrades and force majeure. The organiser is not liable for any material or non-material damage caused by inaccessibility of the website.

The organiser reserves the right to amend and change the marathon's terms and condition that will be published on the website www.okolipohorja.si.

The participants are informed about the terms and conditions and will abide by them.

The terms and condition enter into force and apply on the day of their publication on the website, which is 20th January 2019.
